

DECLARING PARTICIPATION IN THE PERFORMANCE MEASUREMENT PROGRAM AND FILING OF THE 2021 REPORTING REQUIREMENTS

- WHEREAS, Benefits to Kandiyohi County for participation in the Minnesota Council on Local Results and Innovation's comprehensive performance measurement program are outlined in MS 6.91 and include eligibility for a reimbursement as set by State statute; and
- WHEREAS, Any county participating in the comprehensive performance measurement program is also exempt from levy limits for taxes, if levy limits are in effect; and
- WHEREAS, Kandiyohi County Board has adopted and implemented at least 10 of the performance measures, as developed by the Council on Local Results and Innovation, and a system to use this information to help plan, budget, manage and evaluate programs and processes for optimal future outcomes; and
- NOW THEREFORE LET IT BE RESOLVED THAT, Kandiyohi County will continue to report the results of the performance measures to its citizenry by the end of the year through publication, direct mailing, and posting on the county's website, or through a public hearing at which the budget and levy will be discussed and public input allowed.

BE IT FURTHER RESOLVED, Kandiyohi County will submit to the Office of the State Auditor the actual results of the performance measures adopted by the county.



In 2011, Kandiyohi County declared to participate in the Performance Measurement Program created by the Council on Local Results and Innovations. The County adopted the ten performance benchmarks developed by the Council and implemented them in 2011. The results of these measures are required to be reported to the Office of the State Auditor on an annual basis. Below are the ten performance measures, goals, and outcomes for 2021:

Public Safety

1. Performance Measure: Group A and Group B Crime Rates (formerly Part I and Part II Crimes)

Performance Goal: To decrease crime rates over 5 years

Outcome: In 2021, the Kandiyohi County Sheriff's Office reported 677 Group A offenses compared to 528 Group A crimes in 2020. We had 146 Part II crimes compared to 330 in 2020. In comparing figures, you can see we had an increase in Group A offenses, and decrease in Group B offenses.

This was first year the new data was compiled completely from the NIBRS (National Incident-Based Reporting System) program. This will create or be a new base line for years going forward. NIBRS information is more accurate and precise and will allow law enforcement better define its needs to fight crime.

Public Works

2. Performance Measure: Average Bridge Sufficiency Rating

Performance Goal: To maintain the county bridge condition to achieve standards as defined by the State of Minnesota.

Outcome: The Kandiyohi County average local bridge planning index is 89.5. Kandiyohi County inspects 121 bridges in the county, which includes township bridges.

Public Health, Social Services

3. Performance Measure: General life expectancy

Performance Goal: To increase life expectancy in Kandiyohi County

Outcome: Minnesota overall: 81.05 (#2, only to Hawaii at 81.30)

4. Performance Measure: Tobacco and Alcohol Use

Performance Goal: To decrease Tobacco and Alcohol use in Kandiyohi County

Outcome: Kandiyohi County adult tobacco use (use tobacco and currently smoke) is 19% and which is right in line with the Minnesota average of 16%. Source: BRFSS 2021 estimates, www.countyhealthrankings.org

Kandiyohi County adult alcohol use (heavy alcohol use and binge drinking) is 22% which is slightly below the Minnesota average of 23% Source: BRFSS 2021 estimates, www.countyhealthrankings.org

Kandiyohi County ranks 23rd of 87 counties in Minnesota for health behavior measures, however we rank 28th of 87 counties for health outcome measures.

Property Records, Valuation, Assessments

6. Performance Measure: Level of Assessment ratio

Performance Goal: Maintain an acceptable ratio of between 90% and 105%

Outcome: Current year 2021

Residential......93.22%

Agricultural (bare land) 97.77%

Commercial...... 99.60%

Agricultural improved and unimproved...98.20%

7. **Performance Measure**: Turn-around time for recording, indexing and returning real estate documents

Performance Goal: Meet MN Statutes 357.182, Subd. 3, 4, & 6 requirements; record and return recordable real estate documents within 10 business days beginning 2011 and later, 90% of the time

Outcome: 99.48% of 2021 recordable real estate documents were recorded and returned within 10 business days, **exceeding** the MN Statue requirements.

Elections

8. Performance Measure: Accuracy of post-election audit (% of ballots counted accurately)

Performance Goal: To maintain 100% accuracy of ballots counted for each elections

Outcome: Kandiyohi County had 100% accuracy of the ballots counted during its post-election audit of all applicable 2021 elections.

Veterans Services

9. Performance Measure: Dollars brought into county for veteran's benefits

Performance Goal: The goal is to increase amount of dollars brought into the County from veteran's benefits. The goal of the County is to continue advertising and receiving training on all new and existing VA benefits.

Outcome: Total Veteran population continues to decrease do to aging, however this means more nursing home and assisting living (pension) housing is needed for Veterans and their spouses. We have worked closely with all the homes in the County to ensure they are asking if the individual is a Veteran or a spouse/widow. Total veteran population is 2,494 according to the VA statistics. Total dollars brought into the county for Veteran's benefits: \$27,754,000.00.

Environment

10. Performance Measure: Amount of hazardous household waste and electronics collected

Performance Goal: The goal of the County is to reduce the level of HHW in the solid waste stream, and educate the residents and businesses on the proper disposal of hazardous waste. The goal for the County is to provide opportunities to the residents of the County for the management of electronics.

Outcome: In 2021, the regional HHW program in Kandiyohi County collected and properly disposed of approximately... Latex: 5,672 gallons, Oil Base: 2,495 gallons, Fuels: 1,540 gallons, Lab Pack Materials: 14,086 pounds, Aerosols: 4,332 pounds, and Ag. Pesticides: 8,592 pounds. Recycled through Paint Exchange. **REUSE**: Latex: 234 gallons, Oil Base: 133 gallons, Aerosols: 392 pounds, Flammable Liquids: 64 gallons and Other: 509 items. **Electronics Collected from SW Inc.:** 105,070 pounds
