

Fire Relief Association 2024 Reporting Deadline

Legislation passed into law during 2023 increases the threshold at which an annual audit is required for fire relief associations. Beginning with reports for the 2023 calendar year, which are filed with the Office of the State Auditor (OSA) during 2024, an audit is required if a relief association's special fund assets or liabilities exceed \$750,000. A relief association that previously was required to be audited that now is below the threshold will no longer require an audit, unless and until the relief association's special fund assets or liabilities exceed \$750,000.

A relief association with special fund assets of less than \$750,000 and special fund liabilities of less than \$750,000 is required to have its annual financial reporting form attested to by a certified public accountant in accordance with agreed-upon procedures (AUP) prescribed by the OSA.

As a convenience we've post here whether, based on relief association 2022 reporting information, an audit or AUP would be required for the 2023 reporting filed during calendar year 2024. In the chart below, the "AUP" will be highlighted yellow if this is a change from the current reporting year.

(Although unlikely, it is possible that a relief association's special fund assets or liabilities may exceed \$750,000 on the 2022 reporting reflected below, but not exceed that threshold on December 31, 2023. A relief association for which this occurs would not be subject to the new threshold for 2023. So, if this occurs, please notify the Pension Division to confirm your audit requirement.)
