<sup>(</sup>a) Data on Life Expectancy come from the National Center for Health Statistics (NCHS) through the National Vital Statistics System (NVSS). The most recent data available are two to four years prior to the reporting date, and are therefore estimates of the current Life Expectancy at birth.

<sup>(</sup>b) There are multiple family and system related factors that can affect the maltreatment recurrence performance measure. Our Federal Standard for this is to be less than 9.1%. The state average is 9.0%. Factors could include but not limited to; specific type of allegations being reported, efforts to decrease placement, increased drug use by families etc.

<sup>(</sup>c) 2021: The reduction in compliance percentage is related to land records/real estate document counts being the highest since 2006. This is a 15% increase over 2020, which was a 35% increase from 2019. This presented challenges for several counties in meeting the compliance turn-around time resulting in the utilization of temporary staff and overtime.
